## CREDIT TERMS

The customer requests that OSWEGO BUILDING SUPPLIES, INC (OBS), sell materials and services on account in consideration of which the customer and OBS agree as follows:

The customer agrees to pay for all goods and services by 10th of the month following purchase.

OBS may change credit terms upon written notice to customer.

The customer agrees to pay a service charge on outstanding balance for which payment has not been received according to the terms stated. The service shall be 1.5% per month of outstanding balance, and shall become part of outstanding balance.

The customer agrees to pay OBS for all costs of collections, attorney's fees, court costs, sheriff fees, bond costs, and lien costs incurred by OBS in collecting all monies due OBS.

The customer agrees to authorize OBS to use a consumer credit report from time to time in connection with the extension of credit represented with this credit application.

If customer is not a corporation, LLC, or LLP, the principal owners will remain personally liable for any debts incurred on the aforesaid account, even if they later change their business to a corporation, LLC, or LLP unless customer serves written notice of said change by certified mail, return receipt requested, to OBS at the address above. Personal liability shall continue for the account balance incurred before notice is received.

The undersigned does hereby authorize and voluntarily consent to allow OBS to disclose any credit information, both individual and corporate, to third party financial companies. All information shall be for the purpose of securing financing.
